**Eye Contact:**

### 5 Fire Fighting Measures

**Suitable Extinguishing Media:**

Use water spray, foam, dry chemical or carbon dioxide. Do not use a solid water stream.

Hazardous combustion products include oxides of carbon, oxides of nitrogen and sodium oxide.

### 6 Accidental Release Measures

**Personal Precautions, Protective Equipment and Emergency Procedures:**

Wear approved dust/particulate filter respirator and full protective clothing. Evacuate all non-essential personnel from affected area. Do not breathe dust. Ensure adequate ventilation. Avoid generating dust.

**Environmental Precautions:**

In the event of a major spill, prevent spillage from entering drains or water courses.

Inform respective authorities in case of seepage into water course or sewage system.

**Methods and Materials for Containment and Cleaning Up:**

Stop leak if safe to do so and sweep granules into a pile and shovel into drums for subsequent disposal. Avoid generating dust. Provide adequate ventilation. Decontaminate spill area with detergent and water.

If product is spilt in liquid form, wipe up small spills with a paper towel or dry rag. Clean up all spills immediately, since spilled materials, even in small quantities, may present a slip hazard. Absorb large spills with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal. Decontaminate spill area with water and detergents.

### 7 Handling and Storage

**Precautions for Safe Handling:**

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

**Conditions for Safe Storage:**

Store in a cool, dry and well ventilated area. Keep container tightly closed when not in use. Protect from excessive humidity. Keep away from strong oxidising agents.
